Minutes of a Meeting of the Industrial Commission of North Dakota

Held on July 30th, 2025, beginning at 9:00 a.m.

Agency representatives joined various portions of the meeting.

Governor Armstrong called the meeting of the Industrial Commission to order at approximately 9:02 a.m.

Ms. Karen Tyler took roll call, and Governor Armstrong, Commissioner Goehring, and Attorney General Wrigley were present.

Governor Armstrong invited the room to stand and join the Commission in saying the Pledge of Allegiance.

NORTH DAKOTA TRANSMISSION AUTHORITY

Mr. Claire Vigesaa presented for consideration of approval the recommended IIJA Grant Re-Award Project Selection. The total requests were for \$11,582,606 and the amount of grant funds available are \$2,602,356. The ND Industrial Commission, acting as the ND Transmission Authority, recommended the following awards be granted:

McLean Electric Cooperative – Upgrading to Dielectric Reclosers - \$515,900

Montana Dakota Utilities - Merricourt Sub-Trans Upgrade - \$2,086,456

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission, acting as the North Dakota Transmission Authority, advance the following grant requests totaling \$2,602,356 to the Department of Energy:

McLean Electric Cooperative, Updating to Dielectric Reclosers - \$515,900

Montana Dakota Utilities, Merricourt Sub-Transmission Upgrade - \$2,086,456

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.

Mr. Vigesaa presented the NDTA Annual Report. The report includes details the two grid reliability studies that were conducted in the last year, the budget for the ND Transmission Authority, various activities and studies, and a list of grid resiliency grant recipients. The full report can be found on the website.

RENEWABLE ENERGY RESEARCH PROGRAM

Mr. Jordan Kannianen presented the Renewable Energy Program Project Management and Financial Report. The program has had 74 cumulative projects with 15 currently active. There is currently \$5,323,560.79 in committed dollars and \$1,415,576.63 available for future projects.

Mr. Kannianen presented for consideration of approval the de-commitment of funds to two previously awarded Renewable Energy projects.

- 1. R-027-031 (Landfill Gas) \$485,000
- 2. R-045-054 (Spiritwood Greenhouse) \$500,000

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission approve the de-commitment of funding to the following projects in the following amounts as recommended by the Industrial Commission Deputy Director:

R-027-037 - Landfill Gas - \$485,000

R-045-054 - Spiritwood Greenhouse - \$500,000

For a total de-commitment of \$985,000 to be returned to the Renewable Energy Fund

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.

NORTH DAKOTA PUBLIC FINANCE AUTHORITY

Ms. DeAnn Ament presented for consideration of approval the following State Revolving Fund Loans:

i. **City of Cando – Drinking Water - \$3,275,000**. The purpose of this loan is to replace cast iron pipe with PVC water main and replace water service lines, curb stops, gate valves and hydrants. The requested loan term is 30-years, and the City will issue revenue bonds payable with water user fees. The average annual payment will be \$23,416.

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission approve the Drinking Water State Revolving Fund loan request of \$3,275,000 for the City of Cando.

ii. **City of Minot – Drinking Water - \$29,575,000**. The purpose of this loan is to identify the composition of the 8,000 unknown service lines and begin replacement of the 280 known lead service lines in the City. The requested loan term is 30-years, and the City will issue revenue bonds payable with water/sewer/storm sewer fees. The average annual payment will be \$283,852.

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission approve the Drinking Water State Revolving Fund loan request of \$29,575,000 for the City of Minot.

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.

iii. Western Area Water Supply Authority – Drinking Water - \$3,000,000 increase to previously approved \$16,500,000. The purpose of this loan is to include system expansion to those without rural water service, capacity expansion to existing rural service areas, and design for the next expansion of the water treatment facility. There are five bulk users, serving a population of 67,552, which includes the Cities of Williston, Watford City, Ray, Tioga, Stanley, Wildrose, Crosby, Fortuna, Noonan, Columbus and Ross. The requested loan term is 30-years, and the Authority will issue revenue bonds payable with user fees. The average annual payment will be \$743,680.

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission approve the Drinking Water State Revolving Fund loan request of \$3,000,000 for the Western Area Water Supply Authority.

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.

- 2. The form of Loan Agreement to be entered into with the Political Subdivision is hereby approved in substantially the form on file and the Executive Director is hereby authorized to execute the same with all such changes and revisions therein as the Executive Director shall approve.

The Executive Director is authorized to fund the Loan from funds on hand in the Drinking Water Loan Fund established under the Indenture upon receipt of the Municipal Securities described in the Political Subdivisions bond resolution, to submit to the Trustee a NDPFA Request pursuant to the Indenture, and to make such other determinations as are required under the Indenture.

Ms. Ament presented a Memo from the NDPFA Advisory Committee regarding SRF Loans Approved Under Policy P-3B.

- i. City of Jamestown Drinking Water \$1,984,000. The purpose of this loan is to replace cast iron water mains, valves and hydrants in a portion of the I-94 West Business Loop. The requested loan term is 20-years, and the City will issue an improvement bond payable with special assessment collections. The annual payment will average \$116,785.
- ii. City of Grand Forks Clean Water \$1,316,000. The purpose of this loan is to construct a storm sewer along 27th Avenue N and N 32nd Street, to be routed to the newly constructed regional stormwater pond. The requested loan term is 30-years, and the City will issue an improvement bond payable with special assessment collections. The annual payment will average \$54,742.

NORTH DAKOTA HOUSING FINANCE AGENCY

Ms. Jennifer Henderson presented a Report on the 2025 Emergency Solutions Grant (ESG) and North Dakota Homeless Grant (NDHG) Recipients.

The report reads in part as follows:

"The agency serves as the administrator for the Federal Emergency Solutions Grant (ESG) and the state appropriated ND Homeless Grant (NDHG). Similar to multifamily programs, the funds are allocated to recipients through the allocation plan which details the eligible activities and the selection criteria for each program.

Emergency Solutions Grant

Program Overview

Emergency Solutions Grants will be utilized to provide services to individuals experiencing homelessness

and those at risk of becoming homeless in the following eligible activities.

- Street Outreach;
- Emergency Shelter;
- Homelessness Prevention;
- Rapid Re-housing Assistance; and
- Homeless Management Information System- HUD required homeless data repository.

Individuals who are seeking homeless prevention services and extended rapid rehousing must meet income limits at 30% area median income. Programs are delivered through local non-profit organizations who are members of the Continuum of Care, the state's homeless response system.

Funding Level

For FY 2025, the federal formula allocation for the small state minimum was \$484,140. ESG requires 100 percent match on all but \$100,000 of the federal allocation or \$384,140. NDHFA uses a portion of NDHG and staffing administrative costs to meet match requirements.

Awards

A total of 18 applications were received requesting \$2.4 million for the \$731,980 available to award. Seven agencies were selected for funding. A summary of the awards is attached.

North Dakota Homeless Grant Program Overview

ND Homeless Grant is modeled after ESG with some minor adjustments. Rents are allowed to exceed fair market rent and individuals served can earn up to 50% area median income.

Funding Level

Biennial allocation \$9.85 million, allocated over two year period. A portion of the fund is used to pay staff administration costs for the program and cover the required federal match for ESG and the Continuum of Care program.

Awards

A total of 26 applications were received requesting over \$7.5 million in funding. Eighteen agencies were selected for funding."

BANK OF NORTH DAKOTA

Mr. Kelvin Hullet presented for consideration of approval Amendments to General Loan Policy related to Letters of Credit, limits on buydowns for establishing borrowing rates, qualifying projects for the Production Enhancement Program, and to adopt new policies related to legislation passed by the sixty-ninth Legislative Assembly.

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission approve the recommended changes to the Bank of North Dakota General Loan Policy related to Letters of Credit, limits on buydowns for establishing borrowing rates, qualifying projects for the Production Enhancement Program, and to adopt new policies related to legislation passed by the sixty-ninth Legislative Assembly.

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.

Mr. Rob Pfennig presented the College SAVE Audit Report. The Independent Auditor's Report states that in their opinion, the basic financial statements present fairly, in all material respects, the fiduciary net position of the Plan as of December 31, 2024 and 2023, and the changes in its fiduciary net position for the years then ended in accordance with accounting principles generally accepted in the United States of America.

Mr. Don Morgan presented the Second Quarter 2025 Performance Highlights. BND's reported assets are \$10.7 billion. The \$4.1 billion securities portfolio is primarily a source of liquidity, and the loan portfolio balance is \$6.2 billion. BND reported earnings of \$93.9 million for the first half of 2025. Interest income exceeded budget by \$9.2 million primarily due to higher rates on securities and increased agriculture and PACE loan volumes, and interest expense reported higher than budget by \$3.3 million due to higher average deposit balances, rates, and Federal funds purchased. Non-interest income year-to-date was negative \$12.7 million and non-interest expense was \$1.1 million under budget.

Mr. Morgan presented the Non-Confidential Committee and Advisory Board Minutes for May 14th and 15th, 2025 meetings for the Commission member's review.

It was moved by Attorney General Wrigley and seconded by Commissioner Goehring that under the authority of North Dakota Century Code Sections 6-09-35, 44-04-18.4, 44-04-19.1, 44-04-19.2, and 54-17.7-12 the Industrial Commission enter executive session for the purpose of Bank of North Dakota Confidential Business, Attorney Consultation, Pipeline Authority Confidentiality Requests and North Dakota Mill and Elevator confidential business.

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.

The Commission is meeting in executive session pursuant to N.D.C.C. 6-09-35 and 44-04-19.2 to consider those items listed on the agenda under Bank of North Dakota Confidential Business. Only Commission members, their staff, Commission staff, and Bank of North Dakota staff will participate in this executive session.

Following the Bank of North Dakota executive session, the Commission is meeting in executive session pursuant to N.D.C.C. 44-04-19.1 and 44-04-19.2 for attorney consultation related to the item listed on the agenda. Only Commission members, their staff, Commission staff, and Department of Mineral Resources staff will participate in this executive session.

Following the attorney consultation executive session, the Commission is meeting in executive session pursuant to N.D.C.C 44-04-18.4, 44-04-19.2 and 54-17.7-12 to consider two Pipeline Authority confidentiality requests. Only Commission members, their staff, Commission staff and Pipeline Authority staff will participate in this executive session.

Following the confidentiality request executive session, the Commission is meeting in executive session pursuant to N.D.C.C. 44-04-18.4 and 44-04-19.2 to consider those items listed on the agenda under North Dakota Mill and Elevator Confidential Business. Only Commission members, their staff, Commission staff, and Mill staff will participate in this executive session.

Any formal action taken by the Commission will occur after it reconvenes in open session.

Governor Armstrong reminded the Commission members and those present in executive session that the discussion must be limited to the announced purposes. The executive session is anticipated to last approximately one hour and will begin at 10:05 a.m.

Mr. Taylor presented a Review of Operations, 4th Quarter Ended June 30, 2025. Sales for the 4th quarter were \$118,201,365 compared to \$122,415,824 last year. Sales for the fiscal year came in at \$476,072,638. Operating costs for the 4th quarter were \$15,233,074 compared to \$14,061,483 last year, an increase of 8.3%. For the 4th quarter, the Mill had a profit of \$9,164,367 compared to a profit of \$5,767,217 last year. The full financial report is available on the website.

Mr. Taylor presented for consideration of approval the FY 2026 Capital Plan.

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission approve the North Dakota Mill and Elevator FY 2026 capital expenditures plan as presented.

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission approve the North Dakota Mill and Elevator FY 2026 gain share plan as presented.

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.

DEPARTMENT OF MINERAL RESOURCES

Mr. Nathan Anderson presented for consideration of approval the following cases:

i. Order 34407 in Case 31675 – Regarding an application of KODA Resources Operating LLC to amend field rules to create and establish overlapping 1920 spacing unit, authorize drilling not to exceed five horizontal wells, and/or such further relief as appropriate.

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission approve Order No. 34407 issued in Case No. 31675, approving the application of KODA Resources Operating, LLC to amend the field rules for the Writing Rock-Bakken Pool, Divide County, ND, to create and establish an overlapping 1920-acre spacing unit comprised of Sections 19, 30, and 31, T.161N., R.101W., authorizing the drilling of a total not to exceed five horizontal wells on said proposed spacing unit, and/or such further relief, thereby denying Phoenix's opposition and alternate development plan.

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.

ii. Order 34409 in Case 31677 – Regarding an application of Continental Resources to amend field rules to create and establish two overlapping 1920 spacing units, authorize drilling on or near section line between existing spacing unites and/or such further relief as appropriate.

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission approve Order No. 34409 issued in Case No. 31677, denying the application of Continental Resources, Inc. to amend the field rules for the Brooklyn-Bakken Pool and/or Dollar Joe-Bakken Pool, Willaims County, ND, to create and establish the following: (i) two overlapping 1920-acre spacing units comprised of Sections 6, 7, and 18; and Sections 19, 30, and 31, T.155N., R.97W., authorizing the drilling of a horizontal well on each proposed overlapping 1920-acre spacing unit; and (ii) four overlapping 3840-acre spacing units comprised of Sections 1, 12, and 13, T.155N., R.98W. and Sections 6, 7, and 18, T.155N., R.97W.; Sections 24, 25, and 36, T.155N., R.98W. and Sections 19, 30, and 31, T.155N., R.97W.; Sections 5, 6, 7, 8, 17, and 18, T.155N., R.97W.; and Sections 19, 20, 29, 30, 31, and 32, T.155N., R.97W., authorizing the drilling of a horizontal well on or near the section line between existing spacing units on each proposed overlapping 3840-acre spacing unit; and/or such further relief.

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.

iii. Order 32768 in Case 29868 – Regarding an application of Spotted Hawk Development LLC to amend field rules to create and establish overlapping 3520 spacing unite, authorize drilling not to exceed eight horizontal wells, and such further relief as appropriate.

It was moved by Commissioner Goehring and seconded by Attorney General Wrigley that the Industrial Commission approve Order No. 32768 issued in Case No. 29868, affirming Order No. 32477 that was signed by the Commission on March 28, 2023 approving the application of Spotted Hawk Development, LLC for an order amending the field rules for the Van Hook-Bakken

Pool, McLean and Dunn Counties, ND, so as to create and establish an overlapping 3520-acre spacing unit comprised of Sections 16, 17, 18, 19, 20, and N/2 of Section 21, T.150N., R.91W., authorizing the drilling of a total not to exceed eight horizontal wells on said proposed overlapping 3520-acre spacing unit, and such other and further relief as appropriate.

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.

Mr. Nathan Anderson presented the Executive Director Oil and Gas Production Update. This update included production levels in North Dakota, Well Counts, Pricing and Activity Levels, and Permits and Completions. The full executive summary can be found on the website.

OFFICE OF THE INDUSTRIAL COMMISSION

Ms. Karen Tyler presented for consideration of approval a Compensation Increase for BND President, Don Morgan.

The memo reads as follows:

"Section 17 of House Bill 1015 adopted by the 69th Legislative Assembly states in part:

The 2025-27 biennium compensation adjustments for permanent state employees are to average 3 percent per eligible employee for the first fiscal year of the biennium and are to average 3 percent per eligible employee for the second year of the biennium. The increases for the first year of the biennium are to be given beginning with the month of July 2025, to be paid in August 2025, and for the second year of the biennium are to be given beginning with the month of July 2026, to be paid in August 2026.

Since joining the Bank as President in August of 2024, Don Morgan has led with excellence and a dedicated commitment to upholding the Bank's mission and serving North Dakota citizens and businesses. The Bank Advisory Board has recommended the following salary increase effective July 1, 2025, and I concur with their recommendation:

On a roll call vote, Governor Armstrong, Attorney General Wrigley, and Commissioner Goehring voted aye. The motion carried unanimously.
