Site prep in early May included plowing planting area with small tractor and 2 bottom plow. Site was then tilled with small tractor 3 times to get soil in best condition to plant.

South McHenry Soil Conservation District planted trees on 5/21/2018.

Trees were watered on 5.22/2018 and on 5/29/2018. Trees were staked on 6/3/2018. We will wait till fall to install tubes to prevent over heating during summer months.

Weed badgering will be performed late summer/early fall 2018, 2019 and 2020.

Our trees were staked in October so this project is complete. Tree survival looks good considering the extreme drought that McHenry County had this summer. In May, 2019 we will replace any trees that did not survive the winter.
