Dear Ms. Fine:

Thank you in advance for considering our request for a grant of \$1.307 million to expand recreation opportunities at Frost Fire Park in partnership with North Dakota Parks and Recreation Department. The grant request will provide funds for a 2018 Quad Skytrac Chair lift that supports both the new Mountain Bike Terrain program (currently under construction) and the Ski/Snowboard amenities.

Fire-Up for Frost Fire is in a \$5.5 million capital campaign with more than \$2 million committed to date. Our goals are to ensure:

- mountain, trail, and river recreation are maintained and developed;
- historical, cultural and geographical stories are told and passed down; and the
- natural beauty of the Pembina Gorge is preserved; while
- providing positive life-changing experiences for those who live in or visit the Pembina Gorge.

The Foundation, a North Dakota nonprofit corporation with a 501c3 designation request pending with the Internal Revenue Service, acquired the 40+ year old Frost Fire business in June 2017. The 11-member board of directors determined the business model was sustainable if capital costs could be raised through private sources, and programming could be expanded to include a four-season world class recreation and leisure destination park. With 1.2 million people in a 2-hour radius, this is an important legacy project to the City of Walhalla, the Rendezvous Region and the State of North Dakota.

Frost Fire's Significance

Frost Fire is in the heart of the Pembina Gorge State Recreation Area. Since 1976, it has been an amenity to the region providing thousands of people recreational activities and live theatre productions. Its patrons, employees and the surrounding business community have come to rely on Frost Fire as a destination park, as well a significant contributor to the region's identity, sense of place, and economic impact.

Ensuring Frost Fire remains open for the public, along with establishment of a private /public partnership with North Dakota Parks and Recreation, has uniquely positioned us to seize more opportunities such as the creation of a Folk School called KANO. In addition, new partnerships with nonprofits such as Anne Carlson Center and the Rendezvous Region will continue to help us build strength.

Talent attraction and retention today looks different. In rural ND, many jobs exist. Attracting talent takes creativity. Social offerings, aesthetics and openness (acceptance of others) are what attracts and attaches people to place. The Pembina Gorge has these. We need this chairlift to continue to develop the recreation opportunities in the Pembina Gorge, which will also enhance the quality of life in cities throughout the region.

Outdoor Heritage Fund Grant Application

The purpose of the North Dakota Outdoor Heritage Fund is to provide funding to state agencies, tribal governments, political subdivisions, and nonprofit organizations, with higher priority given to projects that enhance conservation practices in this state by:



<u>Directive A</u>. Providing access to private and public lands for sportsmen, including projects that create fish and wildlife habitat and provide access for sportsmen;

<u>Directive B</u>. Improving, maintaining and restoring water quality, soil conditions, plant diversity, animal systems and by supporting other practices of stewardship to enhance farming and ranching;

- C. Any activity that would interfere, disrupt, or prevent activities associated with surface coal mining operations; sand, gravel, or scoria extraction activities; oil and gas operations; or other energy facility or infrastructure development;
- D. The acquisition of land or to encumber any land for a term longer than twenty years; or
- E. Projects outside this state or projects that are beyond the scope of defined activities that fulfill the purposes of Chapter 54-17.8 of the North Dakota Century Code.

NO CONSIDERATION:

In addition to those specific items in law that are ineligible for funding, in the absence of a finding of exceptional circumstances by the Industrial Commission, the following projects will NOT receive consideration for funding:

- A completed project or project commenced before the grant application is submitted;
- A feasibility or research study;
- Maintenance costs:
- A paving project for a road or parking lot;
- · A swimming pool or aquatic park;
- Personal property that is not affixed to the land;
- Playground equipment, except that grant funds may be provided for up to 25% of the cost of the equipment not exceeding \$10,000 per project and all playground equipment grants may not exceed 5% of the total grants per year (see Budget Form for how this will be calculated);
- Staffing or outside consultants except for costs for staffing or an outside consultant to design and implement an approved project based on the documented need of the applicant and the expenditures may not exceed 5% of the grant to a grantee if the grant exceeds \$250,000 and

- expenditures may not exceed 10% of the grant to a grantee if the grant is \$250,000 or less (see Budget Form for how this will be calculated);
- A building except for a building that is included as part of a comprehensive conservation plan for a new or expanded recreational project (see Budget Form for definition of comprehensive conservation plan and new or expanded recreational project); or
- A project in which the applicant is not directly involved in the execution and completion of the project.

The Request and Timeline

The Pembina Gorge Foundation (PGF) is seeking assistance from the Outdoor Heritage Fund (OHF) to purchase and install a new chairlift at the Frost Fire Park with a total estimated cost of \$2,472,890. The PGF requests \$1,307,168 (53%) from the OHF and commits the matching funds of \$635,723 (26% from a private donors and Cavalier Rural Electric Cooperative). The remaining funds of \$530,000 are investments made by ND Parks and Recreation Department (21%). The new chairlift is required as the existing lift has been deemed unsafe and inoperable due to its age of nearly 70 years. The new chairlift will be installed in 2018 in time to serve the 2018-2019 ski season and spring mountain bike season.

PGF Bought Frost Fire in 2017

The PGF purchased the Frost Fire property in June 2017 to preserve and enhance recreation and cultural opportunities in northeastern North Dakota. The business was developed, opened and maintained by the Judith and the late Richard Johnson as a family business for more than 40 years. The Johnsons sought the sale to a nonprofit foundation, in partnership with an array of public and private partners, to allow public outdoor recreation to continue for generations to come and build on the legacy they began on Christmas Day 1976. The PGF's total capital campaign is currently \$5.5 million. Frost Fire Park is approximately 175 acres and includes 40 acres of forestry land and is along the Pembina River.

With a new and expanded business model and public partnerships, the recreational opportunities and accessibility are being greatly expanded within the Pembina Gorge. At its peak, Frost Fire served 20,000 skiers, snowboarders, tubers and theatre goers and is now between 10,000 to 15,000 customers. There are more than 1.2 million people living within a two-hour radius of the Pembina Gorge.

Public Partnership with North Dakota Parks and Recreation (NDPRD)

The PGF is in a private public partnership with NDPRD to enhance the experience of outdoor recreation enthusiasts in the Pembina Gorge. NDPRD relocated its Walhalla staff to Frost Fire lodge in January 2016. Through the PGF's acquisition of Frost Fire, NDPRD is now able to explore achieving seven of the 16 priorities in its Pembina Gorge State Recreation Area Master Plan (December 2014). Most immediately, the relationship provided a visitor center. This partnership is a win/win for both entities and assists in leveraging resources from private and public sources to continue to build recreation, cultural, historical, natural and hospitality amenities both at Frost Fire as well as the entire Pembina Gorge.

New Bike Park Under Construction at Frost Fire

In summer 2017, NDPRD began construction of the Frost Fire Bike Park on the slopes at Frost Fire with an estimated cost of \$232,000 – 90% of which was federally funded. Studies have shown the bike park has potential to draw bikers from an eight-hour radius. This is will be the first of its kind bike park in North Dakota and makes Frost Fire Park nearly a 12-month recreation amenity rather than primarily the winter season of December through March. The PGF's chair lift will also be utilized bike park users. The PGF has estimated 4,800 bikers will ride year one. This was based upon 80% of the users year one at Detroit Mountain's bike park in Detroit Lakes, MN. The region is becoming a key recreation destination.








Figure 2 Mountain Bike Terrain Park Concepts

PGF incorporated as a North Dakota nonprofit in January 2017 with a mission "to preserve and enhance the experience of the Pembina Gorge while connecting people to positive, life changing experiences. The Foundation develops and supports historical, cultural, education, natural, interpretive and recreational opportunities in the Gorge." There are 11 members of the board of directors, two ex-officio members, an interim foundation director, operations manager and hospitality manager.

The foundation's immediate goal was to purchase Frost Fire from Judith Johnson and build on the long history of success. Opening Christmas Day 1976, the Johnsons catered to outdoor recreation enthusiasts with downhill and cross-country skiing, snowboarding and tubing, summer theatre and

cafeteria. The Johnson's legacy was to see the park remain open to the public and develop into the wondrous destination they dreamt possible with help of philanthropy, partnerships and grants.

The PGF continues the same activities and is expanding recreation through a partnership with ND Parks and Recreation Department (NDPRD). NDPRD began construction of a mountain bike terrain park on the slopes at Frost Fire Park in 2017 to be finished and open to the public by September 2018. A copy of the Frost Fire Bike Park Master Plan is available upon request. Unfortunately, the unsafe condition of an aged chairlift, winter activities the past two seasons has been limited to tubing.

Replace Chairlift is Critical to Future of Frost Fire Park and Pembina Gorge State Recreation Area in 2018

The PGF proposes replacing the existing, inoperable triple chair lift with a quad chair lift located at Frost Fire Park. The chairlift is critical to the PGF meeting its goal of maintaining the vital recreational destination and making this business sustainable for the near and long term. Without a new chair lift in 2018, the PGF will face significant challenges that could result in closing the operation until which time philanthropic and grant funds are raised to reopen the facility. Currently, the fundraising goal for the entire project undertaken by the PGF is \$5.5 million with \$1.5 million raised to date.

For example, Detroit Mountain, a similar facility located near Detroit Lakes, MN, was closed from 2004 to 2015 and is now owned and operated as a premiere year-round recreation area by Detroit Mountain Recreation Area, Inc., a nonprofit corporation. It is the PGF's goal to avoid a similar shut down as resurrecting the project would be extremely challenging as well as present challenges to the implementation of the NDPRD's 2014 Pembina Gorge State Recreation Area Master Plan.

Goals and Benefits of Replacing Chairlift

The goals and benefits of replacing the chair lift include:

- The chairlift will expand recreation opportunities to nearly 12 months of the year as it will support the new mountain bike terrain park currently under construction on the slopes at Frost Fire in partnership with ND Parks and Recreation Department.
 - The mountain bike park will be the first of its kind in North Dakota.
 - The mountain bike park will open in mid-summer 2018.
 - ND Parks and Recreation is investing approximately \$230,000 into the construction of the mountain bike park. This funding was secured from the federal Recreation Trails Program (90%) and the Department (10%).
 - The Department has a Memorandum of Understanding with the Pembina Gorge Foundation and is developing an operating agreement whereby the Department will manage the trail and the Foundation will operate the chairlift for mountain bikers.
 - Studies show a mountain bike terrain park will draw bikers from up to an eight-hour radius.
- The chairlift will support downhill skiing, snowboarding, mountain biking (new), and scenic viewing (new).
- The chairlift is instrumental to making the Pembina Gorge a recreation destination. The new chairlift will have an expected useful life, with proper maintenance, of approximately 30 years.
- The inoperable chairlift being replaced was installed in used condition in the mid-1980s with original manufacturing dating back to 1950s.
- The existing chairlift was not safe or operable during the 2017-2018 winter season and was recommended to be replaced (this was not known at the time of purchase).
- Winter customers have historically accounted for 80% of the clientele and the mountain bike park could turn these recreation enthusiasts to year-round users. Expanding the business model to potentially 12 months of the year will greatly enhance the sustainability of Frost Fire for generations to come.

The existing triple chair lift, installed in the late 1970s, has exceeded its useful life and is currently in a state of disrepair due to severe wet conditions sustained in 2016. An engineer has deemed the existing lift as unrepairable. NDPRD is currently constructing a mountain bike terrain park at Frost Fire in partnership with the PGF which will result in year-round use of the proposed ski lift.

Innovation: Private Public Partnerships Maximize Recreation and Cultural Amenities

The PGF acquisition of Frost Fire Park has increased the level of commitment and leadership significantly by providing a plan for sustainability as well as increasing the recreational and cultural activities. An abbreviated PGF strategic plan is included in **Exhibit 1**.

Through strong partnerships with ND Parks and Recreation, ND Tourism, ND Department of Commerce and local, county, regional, state and federal entities (many of whom have provided letters of support to this application), the Pembina Gorge is poised to be a recreational destination of significant attraction. For more than 40 years, this area has slowly and steadily built the recreational assets that are now in a position to become a focal attraction for the State of North Dakota.

In 2015, ND Parks and Recreation relocated its Walhalla office to Frost Fire. Close proximity to Canada (10 miles), draws international visitors. Special events such as the annual Wilderman Triathlon and Fossil Dig draw people from throughout the United States and Europe. It is these recreational amenities that also greatly enhance the quality of life for the people in northeastern North Dakota. Frost Fire Park now offers recreation for people ages 2 to 92.

Projects Meets Two OHF Directives

The proposed project meets the following OHF directives:

• Directive A: Providing access to private and public lands for sportsmen, including projects that create fish and wildlife habitat and provide access for sportsmen.

ND Parks and Recreation is working to make Frost Fire Park and trailhead for its 30+ miles of multi-use trails. Frost Fire will be open to the public to access land, forested areas and trails. Frost Fire has a multi-use that ND Parks and Recreation has secured funds to connect to its trail system.

Also, in 2017, NDPRD secured funds to build a connector trail from Frost Fire to the state's 30+ mile multi-use trail. This connector trail will enable trail users to use Frost Fire as a trailhead and hospitality hub to receive State Recreation Area information and guidance from NDPRD staff. It's the goal of both the PGF and the NDPRD to have a seamless customer experience for all recreation offerings within the Pembina Gorge.

• Directive D: Conserving natural areas and creating other areas for recreation through the establishment and development of parks and other recreation areas.

Expanding recreation in the Pembina Gorge through the Mountain Bike Terrain Park in partnership with ND Parks and Recreation brings new recreation opportunities to patrons from a wide service area (studies show up to 8-hour radius). The new chairlift will also reestablish downhill skiing and snowboarding during the winter months which has been absent the past two winter seasons.

Honoring the Conservation Legacy

Key partners in building and supporting the PGF are Tim and Sandy (Johnson) Crary, originally from Walhalla, both have a long and wonderful family history to the Pembina Gorge. Sandy's father, Bert Johnson, was a farmer who instilled a love of the land and a deep respect

for the area. Tim's father, Paul T. Crary, was awarded the first national honor for his conservation work to save the trees in the Pembina Gorge in 1969. Sandy and Tim are continuing their legacy to preserve, protect and enrich the Pembina Gorge to its full potential for their children, grandchildren, and really for generations to come.


Frost Fire Park and State Recreation Area Meet Main Street Initiative Objectives

Aside from the OHF Directives, this project as well as the implementation of both the PGF and Pembina Gorge State Recreation Area Master Plans, achieves objectives that stretch well beyond recreation.

Governor Burgum's Main Street Initiative has three pillars: healthy vibrant communities; 21st century workforce; and smart and efficient infrastructure. Keeping Frost Fire Park available to the public while also expanding it through the new programming and amenities described in this application really serves all of the three Main Street Initiative goals. At its peak, Frost Fire had 20,000 customers. There are 1.2 million people living within two hours of the Pembina Gorge as an easy day trip to this recreation destination. The customers are not only vital to the sustainability and transformation of Frost Fire, but to the entire region. Frost Fire customers also purchase fuel, groceries, meals, and more during their trips to the Pembina Gorge and the surrounding area. These customers help maintain main street businesses that struggle to survive in rural North Dakota due to continued population decline.

A significant motivator behind this project over the past five years was the persistent 70-years of population loss sustained in the Rendezvous Region (Cavalier, Pembina and Walsh Counties). Since 1990 alone, these three counties have sustained a loss of 7,300 people – which could be translated to the current combined populations of the cities of Park River, Grafton and Langdon.

One of the key economic development strategies for this region has become "people attraction." These three counties have 1,200



manufacturing and food processing jobs yet, these counties continue to loss people. These employers have continually stated that their number one challenge and barrier to growth is availability of quality workforce. It is an economic development goal to round out the community amenities for family to consider northeastern North Dakota a much-sought after place to live due to its unique recreational amenities available year-round.

Having strong, healthy, high quality recreational amenities are vital for northeastern North Dakota for quality of life, attracting and retaining workforce, and having differentiated communities that draw both visitors and residents.

Lastly, this project makes use of existing infrastructure. The existing infrastructure in this case was the sustainability of a 40+ year old business that survived during the ups and downs of a weather-dependent business such as this. The existing facility can now be enhanced and expanded upon as is currently being done with both the mountain bike terrain park and the KANO folk school. Had the

PGF not purchased Frost Fire, NDPRD would not have invested in the construction of the mountain bike terrain park or secured funds to connect Frost Fire to the state's 30+ mile trail system.

The new chairlift will be purchased and installed by Sky Trac Aerial Transportation Systems, Salt Lake City, Utah, with construction proposed as soon as weather permits in 2018 to be fully functional for the 2018-2019 winter season. Additional project oversight will be provided by the Board of Directors which includes Dustin Gorder, who has extensive ski resort experience. Sky Trac certifies to provide a turn-key chairlift upon completion of the installation. The chairlift is a vital, necessary investment for both the short and long-term sustainability of Frost Fire Park. The chairlift replacement is an investment that is expected to have a useful life of at least 30 years with proper routine maintenance. The PGF commits to proper maintenance and will allocate the necessary funds for maintenance both through revenue generated from its operation as well as endowment fund proceeds.

The chairlift is also the backbone piece of equipment to the entire Frost Fire Park – without it, much of the recreational benefit of Frost Fire is not accessible and the business model is not sustainable. Chairlift related activities including skiing, snowboarding, and mountain biking are an estimated 65% of the total projected revenue to the PGF in 2019.

The PGF total capital campaign calls for approximately \$5.5 million over the next couple of years. The North Dakota Parks and Recreation Department (Department) officially opened the Pembina Gorge State Recreation Area in 2012. Since that time, the Pembina Gorge has grown in popularity as people are ever looking at ways to explore this unique landscape. In 2014, a public process was initiated to create a master plan with the intent to guide the management and development of the Pembina Gorge. The plan highlighted the need for an expansion of services that the department could not achieve without establishing partnerships.

The partnership with the Pembina Gorge Foundation was fostered through their efforts to acquire the Frost Fire Ski and Snowboard Area. Through this partnership we were able to meet five of the top six priorities outlined in the master plan. These priorities ranged from providing a visitor center for visitor information, centralized enforcement, maintenance staff for upkeep and more trail development.

Starting in 2016, the Department, in coordination with the Pembina Gorge Foundation, started a planning process to develop a mountain bike terrain park on the Frost Fire property. This effort was a step towards meeting the trail needs outlined in the master plan and extending the season of use of the amenities at Frost Fire. The Department attained a Recreational Trails Program grant to help develop Phase I including a novice and intermediate skill level mountain bike course. When completed the users can utilize the ski lift to access the top of the mountain bike runs and use gravity to ride down. These runs will open summer of this year and the project has received a lot of interest.

At the time of planning and preliminary construction of the mountain bike terrain park, the ski lift was thought to be operational. The ski lift is crucial for the success of the mountain bike terrain park and the winter skiing operations in the Pembina Gorge. The grant request from the Pembina Gorge Foundation meets objectives within the Pembina Gorge State Recreation Area Master Plan to develop more multi-use and multi-season trails with the amenities to support these activities.

Frost Fire is undergoing an entrepreneurial renewal to expand and enhance their outdoor offerings, and your funding will be highly leveraged and most useful.

The new Frost Fire chairlift will support downhill skiing, snowboarding, mountain biking, and scenic viewing in one of our state's most scenic and valuable outdoor attractions — the Pembina Gorge. The Pembina Gorge west encompasses one of the largest uninterrupted woodland areas in North Dakota of approximately 12,500 acres and offers the longest segment of unaltered river valley in the state. ND Parks and Recreation Department: Pembina Gorge State Recreation Area Operations

The Pembina Gorge State Recreation Area (SRA) is 4,400 acres of state-owned lands located about seven miles west of Walhalla. The State of North Dakota established the SRA in 2005 and ND Parks and Recreation Department has managed it for public recreation and resource conservation. SRA visitors come from North Dakota, northeast Minnesota, and Manitoba.

The State has taken several development steps of the SRA since 2005. Highlights are:

- 2005: Governor Hoeven allocated money to study and create a master plan for trail development in the Pembina Gorge area.
- 2007: Project manager was hired to assess, inventory trails in the area, identify sustainable trail corridor for a multiuse trail system, and manage the lands associated. The primary goal of the recreation area is to protect public and private lands by limiting illegal off highway vehicle (OHV) use in the Pembina Gorge through development of a managed multiuse trail corridor open to the public.
- 2009: ND Parks and Recreation assumed recreation management of the Tetrault Woods State Forest. Invested \$48,000 to build trailhead and reroute and rehabilitate the trails in the state forest (non-motorized).
- 2011: Primary trail corridor for OHVs was designed and constructed new and exciting trails in the area with \$138,864 Recreation Trails Program through the Federal Highway Administration.
- 2013: Legislative proposal to purchase Frost Fire for \$2 million passed the House of Representatives and failed in the Senate. \$300,000 was appropriated to support the development of a SRA Master Plan.
- 2014: Pembina Gorge State Recreation Area Master Plan was developed with input from more than 250 stakeholders and three public meetings.
- 2016: The following is a list of projects with funds secured for construction in 2017 by ND Parks and Recreation Department:

Downhill mountain bike trails	\$250,000 (currently under construction – operational
	summer 2018 at Frost Fire)
Frost Fire to multi-use trail	\$231,250 (connect Frost Fire to state trail system)

Note: The funding for the mountain bike trails and multi-use trails (\$481,250) has been secured and committed for construction in 2017. However, this investment was

conditioned upon the Pembina Gorge Foundation securing the property in spring 2017.

- Trail grooming for winter non-motorized recreation.
- Develop cabins or yurts as lodging in the area.







OVERVIEW

The Forst Fire Bike Park is located outside Walhalla, ND in the Pebmina River Gorge. The designed trails will be located on a 80 acre area within the ski area boundary. The trail are mountain bike specific downhill trails that will be served by the ski lifts. In addition to the lift access trails there will be climbing trail that will access the top of the mountain.


Progressive Trail Design and Progressive Bike Ramps were hired by The Frost Fire Ski Area to develop a Master Plan for the trails... The following Frost Fire Bike Park Master Plan is intended to provided recommendations for the overall trails, and an appropriate phasing plan. The Frost Fire Bike Park Master Plan is a valuable planning tool that will provide a strategic guide for future trails.

SITE ASSESSMENT

The Frost Fire Ski Area is in the heart of the Pembina River Gorge with beautiful views overlooking the Pembina River. The ski area consist of 2 lifts and 1 magic carpet with 9 ski runs ranging from green [beginner] to black [advanced] in difficulty. The bike park is designed around the triple chair lift and all the gravity trails will begin there. With 300 feet of elevation the ski area provides many opportunities to build a high quality bike park with multiple trails for all level of riders. The sandy and shale like soils do not provide the best soil types for flow trails, however the use of prefabricated features will provide a low maintenance alternative. There is ample side slopes and wooded areas to provide a variety of trails and draw riders for the surrounding areas to come out and enjoy.

The proposed trails consists of 6 downhill mountain bike trails, 1 climbing trail, and a skills center. The downhill mountain bike trails are designed for different levels of experience from beginner to expert. The climbing trail will allow for riders to access the top of the lift using their own strength. The skills center, located at the main lodge and parking, will allow users to work on their skills before dropping into the trails.

There are 6 downhill trails, a climbing trail, pumptrack and skills course.

DOWNHILL MOUNTAIN BIKE TRAILS

- · 6 distinct mountain bike specific directional downhill trails.
- · Beginner downhill flow trail
- · Intermediate downhill flow trail
- · Expert downhill flow trail
- · Intermediate downhill technical trail
- · Expert downhill technical trail

CLIMBING TRAIL

· Climbing only trail designed for riders who want to pedal to the top of the mountain instead of using the lift.

SKILLS CENTER

- · SKILLS COURSE: Short loop trail with features designed for beginner and novice riders. Near the main lodge and parking.
- PUMP TRACK: Designed as a continuous loop. Custom concrete pumptrack for all level of riders

It is important to note that all the proposed trails in this plan are conceptual alignments based on fieldwork. They are all subject to be further refined on the ground during the pre-construction final design phase. This plan is to be used as a guide for the future development of the Frost Fire Bike Park.

The trails and skills center final tread will be "Natural Surface" that will range in width and character. They are proposed to provide a diverse experience for a variety of users, introducing difficulty level progression by adding beginner, intermediate, and advanced options. The following pages are a description with support images of the different types of the proposed trails and amenities.

GRAVITY DOWNHILL TRAILS

The area off of the triple chair offers great opportunities for lift access trails. The trails will all begin at the top of the lift and finish at the bottom utilizing the tree islands as much as possible. The intermediate trails will use the area just outside the ski boundary to the south. This area has not been clear cut for ski runs and provides more opportunities for trails winding through the woods. The other trails will wind through the tree islands in between the ski runs. Due to the low quality soils prefabricated features will be used to provide a low maintenance alternative to dirt jumps and features. On the more technical trails rock will be brought in to create drops and rock gardens throughout the trail.

BEGINNER DH FLOW TRAIL

The Beginner DH flow trail will have small rollers, berms, and dirt jumps built at a beginner level. All of the obstacles on this trail are "rollable" meaning that no matter how fast or slow one rides the trail; one can roll over or roll through the trail with relative ease.

INTERMEDIATE DH FLOW TRAIL

The Intermediate DH flow trail will have larger rollers, berms, prefabricated jumps and technical features throughout the trail. PBR prefabricated kickers will be used for all the jumps with dirt landings. All features will be built at an intermediate level and will not have any mandatory gaps. The intermediate line is designed to be a progressive step up from the beginner line, which will prepare the rider for the expert line.

ADVANCED DH FLOW TRAIL


The Advanced DH flow trail is where each rider needs to be prepared for big moves. The Advanced DH trail will have large rollers, berms, prefabricated jumps, and technical features throughout. All the jumps will be dirt landing with PBR prefabricated kicker. The jumps will be table top, but the distance from lip to landing will be much larger than the intermediate lines. This level of trail will have mandatory drops, big features, and will create a lot of speed. If the "qualifier" [feature that starts each trail] is intimidating then one should reconsider riding this trail as it sets the tone for the trail, and prepares the rider for what lies ahead.















INTERMEDIATE TECHNICAL DH TRAIL

The Intermediate DH tech trail will be a narrow steep trail with technical rock features throughout. Rock drops and rock gardens will be built into the trail. All features will be built at an intermediate level and will not have any mandatory gaps. The intermediate line is designed to be a progressive step up from the beginner line, which will prepare the rider for the expert line.

EXPERT TECHNICAL DH TRAIL

The Expert DH trail will be steep and technical with large rock drops and rock gardens. This level of trail will have mandatory drops, big features, and will create a lot of speed. It will be built off of the Advanced DH flow trail which will prepare riders for a trail of this level of difficulty.



CLIMBING TRAIL

The Climbing Trail is designed for uphill mountain bike traffic only. It will be a natural surface single track trail ranging in width from two to three feet. It climbs up from the bottom of the lift and connect to the main lodge and continuing up to the top of the lift. It provides the main access to the downhill trails without taking the lift.






SKILLS COURSE

A Skills Course is a playground-like facility comprised of a variety of elevated features, such as "ladder bridges" and "skinnys", designed to teach balance and technical handling skills. They are commonly constructed in flat open areas. Along with pumptracks they are the core beginner amenities that promote basic bike handling skills before progressing to more advanced features.













PUMPTRACK

A Pumptrack is a closed circuit track consisting of rollers, and berms shaped and spaced to allow riders to generate and maintain speed without pedaling. They are designed to teach riders how to pump to generate speed and to improve a rider's cornering abilities. They are built in flat areas and typically 125 feet in length to 300' in length.









KAYNO (Kay-no)



The first systems of writing developed and used by the Nordic peoples were runic alphabets. The runes functioned as letters, but they were also a symbol of a principle or power. To write a rune was to invoke and direct the force for which it stood.

Kayno (KAY-no) is the Norse rune representing divine inspiration. Its significance is related to fire, light, warmth, enlightenment and knowledge. It shed's light on the path helping us to see with true discernment. It suggests that understanding must lead to action and light in the darkness implies spiritual illumination. This is the rune of the artisan and it is often used in reference to those engaged in artistic ventures or seeking creative solutions.

The runes were traditionally carved into stone, wood, bone, metal or some similar hard surface rather than drawn with ink and pen on parchment. This explains their sharp angular form. which was well suited to that medium.
