Budget Narrative

Budget Narrative:

10 new sites will be enrolled into the Urban Woods and Prairies Initiative and will be restored/enhanced and managed throughout the project period. Audubon Dakota collected estimates from Minnesota Native Landscapes to calculate the restoration/ enhancement and 3-year resource management expenses based on acreage and industry standard costs for urban conservation throughout the project cities. In total, Audubon Dakota is requesting \$591,200 to impact 320 acres throughout the grant period.

Audubon Dakota's Urban Conservation will lead project management. This position's salary is estimated at \$45,000/year, with 32% fringe at \$14,400. Audubon Dakota is requesting support for a portion of this position's time and fringe benefits, for a total of \$29,560.

Audubon Dakota will commit \$20,000 of in-kind match through staff time dedicated to the UWP Initiative, including partnership development, administration, and project management. Additionally, Audubon Dakota will commit \$10,000 of cash match toward interpretative signage to be installed at each UWP nature park to provide educational opportunities for park visitors.

Landowning project partners will be responsible for conducting site preparation (mowing, tilling, and herbicide application) among other maintenance costs, in addition to outreach and planning activities associated with the enrolled sites. Their in-kind match is estimated at \$177,360.

Abstract/Executive Summary

Abstract/Executive Summary*:

The Urban Woods and Prairies (UWP) Initiative is the premier urban habitat restoration program in the Northern Great Plains. Established by an OHF grant in 2014, the project has grown from 150 acres along Fargo's Red River to over 750 acres across 5 cities. Currently, the 33 enrolled sites are in various stages of restoration and development. Pilot sites restored in 2015 have transitioned to minimal maintenance plans, as they are fully established with high quality native grasses and wildflowers that local communities enjoy exploring. Sites enrolled between 2017 and 2021 are undergoing integrated prairie management, which includes practices such as spot spraying, mowing, and enhancement seedings with the goal of controlling invasive species and increasing native vegetation composition.

Audubon Dakota is seeking support from the ND OHF of \$620,760 to further expand UWP in the cities of Fargo, Minot, Jamestown, and Valley City to impact 320 acres. By establishing the first UWP sites in Jamestown and Valley City, Audubon aims to create a UWP nature park within walking distance of 70% of ND's population by 2023 to promote a more extensive initiative around restoring habitat in urban areas, increase outdoor recreation for the communities, and valuable outdoor education space. With this project, Audubon Dakota will build upon the proven UWP model and success of the 2018 UWP Expansion OHF grant, which will be completed and fully expensed by June 30, 2021, impacting a total of 429 acres.

Through the UWP Initiative, communities across ND will benefit from the variety of ecological services that native habitat provides, such as erosion control and water filtration. In addition, flood resiliency within each city is expected to be enhanced. Adding and improving native habitat to these cities will also increase wildlife presence and provide breeding habitat for woodland birds, grassland birds, waterfowl, and our State bird - the Western Meadowlark. With an increased number of species inhabiting these areas, there comes more opportunity to perform environmental education and nature-based outreach events to educate the public about the importance of the project and improve understanding of native habitat's role in the environment.

The UWP Initiative Phase II is a 5-year project. Year 1 is designated for site selection, planning, and seedbed preparation. Year 2 will focus on the implementation of habitat improvements. Years 3 through 5 are reserved for the 3-year integrated prairie management practices necessary for habitat establishment success. After the professional installation and management, maintenance responsibility is turned over to the landowning partners who commit to adapting and following the habitat management plan as needed with support and guidance from Audubon Dakota. The key partners in this project will be Audubon Dakota, Fargo Park District, City of Fargo, Minot Park District, City of Minot, City of Jamestown, and Barnes County Park Board.

Project Duration

Year one (July 1, 2021 - June 30, 2022) will be primarily focused on developing site plans, executing Memoranda of Understanding with partner landowners, and preparing site seed beds. Initial habitat installation and improvements will begin in the spring of year two. Years three through five are reserved for the 3-year integrated prairie management practices necessary to achieve success during native prairie establishment.

Organization Information*:

Audubon Dakota is the state office of the National Audubon Society serving North Dakota, South Dakota, and parts of Minnesota, Nebraska and Montana. Since 1905, the National Audubon Society has upheld the mission of protecting birds and the places they need, today and tomorrow. Audubon Dakota was instituted in 1997, though Audubon's role in the Dakotas spans back to the mid-1970s. Currently, Audubon Dakota has helped conserve over 350,000 acres in the Dakotas through various programs focusing on the conservation priority strategies of Working Lands and Bird Friendly Communities. Working Lands programs include the Outdoor Heritage Fund supported Prairie Management Toolboxes and Conservation Forage Program as well as the North Dakota Prescribed Fire Cooperative and Audubon Conservation Ranching Initiative. Bird Friendly Communities programming is achieved through the Urban Woods and Prairies Initiative and comprehensive engagement efforts.

Audubon fosters partnerships that advance its habitat conservation goals, including supporting grassland habitat projects, Private Lands Open to Sportsmen, and the ranching industry. As a state office, Audubon Dakota has eight full time staff members for the two-state region (North and South Dakota). Audubon Dakota's Advisory Board is comprised of eight North Dakota citizens with backgrounds ranging from agriculture, science, politics, medicine, law, finance, and education. Through multiple annual volunteer events focused on stewardship and education, Audubon Dakota organizes nearly 50 volunteers each year and engages 30,000 people.

For all of our programs, the efforts and cooperation of our supporters is crucial to our success and the conservation of bird habitat in the Dakotas.

Purpose of Grant*:

Trending towards Audubon Dakota's strategic plan of establishing an Urban Woods and Prairies (UWP) Initiative nature park within walking distance of 70% of North Dakota's population, the Urban Woods and Prairies Initiative Statewide Expansion will restore and enhance up to 320 acres across 10 sites in North Dakota. While not new as a concept, expanding UWP to new cities beyond North Dakota's most urbanized communities is a new project focused on the restoration of woodland and grassland habitats for outdoor recreation, wildlife habitat, and environmental education. In doing so, this proposal will carry out the Outdoor Heritage Fund's Directive C to develop, enhance, conserve, and restore wildlife and fish habitat on private and public lands; as well as Directive D to conserve natural areas for recreation through the establishment and development of parks and other recreation areas.

In 2014, with essential support from the Outdoor Heritage Fund, Audubon Dakota and partners developed the UWP Initiative to create healthy grassland, wetland, and riparian habitat for declining bird species within the urban landscape as well as create natural space for the community to enjoy. Currently, there are 750 acres of riparian woodlands and uplands enrolled in 33 sites across five cities as UWP nature parks, open to the public. The establishment of native vegetation provides a variety of ecological services that is lacking in traditional turf grass regimes. Native plants have extensive root systems that help increase water quality and bank stabilization, decrease soil erosion, and sequester carbon while also requiring little maintenance. Restored wetlands also facilitate in flood mitigation.

Through UWP's second expansion, land that is otherwise idle due to flood buyouts or frequently mowed to control invasive species can be managed through native seeding and directed invasive plant species removal. The most common species seen in these areas include Kentucky Bluegrass, Smooth Brome, Canada Thistle, Leafy Spurge, and Common Buckthorn. Not only do these species diminish the quality of avian and wildlife habitat, but if left unchecked can spread rapidly and degrade even the most maintained gardens. Native species, such as Big Bluestem, Little Bluestem, Indian Grass, and Switch Grass are desirable for wildlife habitat and are native to the region. By restoring areas with higher forb seed densities, wildflowers such as Black-eyed Susan, Purple Prairie Clover, and Common Milkweed can promote habitat for pollinators and create esthetically pleasing areas for the community to explore.

To aid in the initial establishment and three-year management of these sites, Audubon and partners will work with local contractors to install native vegetation through seeding and maintenance of each site for 3 years including herbicide application and prescribed burning. These contractors will also take an aggressive approach to dealing with invasive woody species, such as Common Buckthorn and Russian Olive in more wooded areas through manual removal and chemical application. Following those 3 years, responsibility of the maintenance would be turned over to the landowner. Audubon Dakota will create a management toolbox for the partners to outline future management goals and objectives of the sites and highlight appropriate management practices while still allowing for adaptive management.

Management of Project*:

From Audubon Dakota, the staff members associated with the project will be Marshall Johnson, Sarah Hewitt, and an urban conservationist.

Marshall Johnson is the Executive Director of Audubon Dakota and has been doing conservation within North Dakota for the past 11 years. His background in business and his leadership skills make him a natural manager for this project.

Sarah Hewitt, Audubon Dakota's conservation programs manager has been with Audubon Dakota for 5 years, and has had technical training in grassland restoration and management in North Dakota, South Dakota, and Minnesota through North Dakota State University and the U.S. Fish and Wildlife Service.

The Urban Conservationist will manage and execute grant goals of expanding the Urban Woods and Prairies Initiative across the state. This position will be essential for successful expansion and management of currently enrolled UWP nature parks in all program cities (Fargo, West Fargo, Grand Forks, Bismarck, Minot, Jamestown, and Valley City).

Sustainability*:

Funding from the ND Outdoor Heritage Fund will support the initial habitat restoration and management of the newly enrolled nature sites. Audubon Dakota and our landowning partners will be responsible for preparing each restoration site under the guidance of the hired contractor, which will include a combination of mowing, tilling, and herbicide application for prairie restoration. After restoration establishment, the native vegetation will require less overall maintenance work than what is currently spent on these areas (mowing hours, staffing, fuel, etc.) which has proven to be extremely cost efficient for landowning partners. Audubon Dakota, having a vested interest in the continuance of habitat on these sites, will also take on financial and management responsibility for the UWP Initiative in order to ensure its sustainability for many years to come.

In addition to strictly financial funding, Audubon Dakota would promote the use of the areas for outdoor recreation and education. This will help gain public favor of the areas and help assure the sustainability of these sites through general community approval. Audubon Dakota will also take on administrative tasks such as scheduling contracted management work to ensure the project is completed in a timely manner.

Partial Funding*:

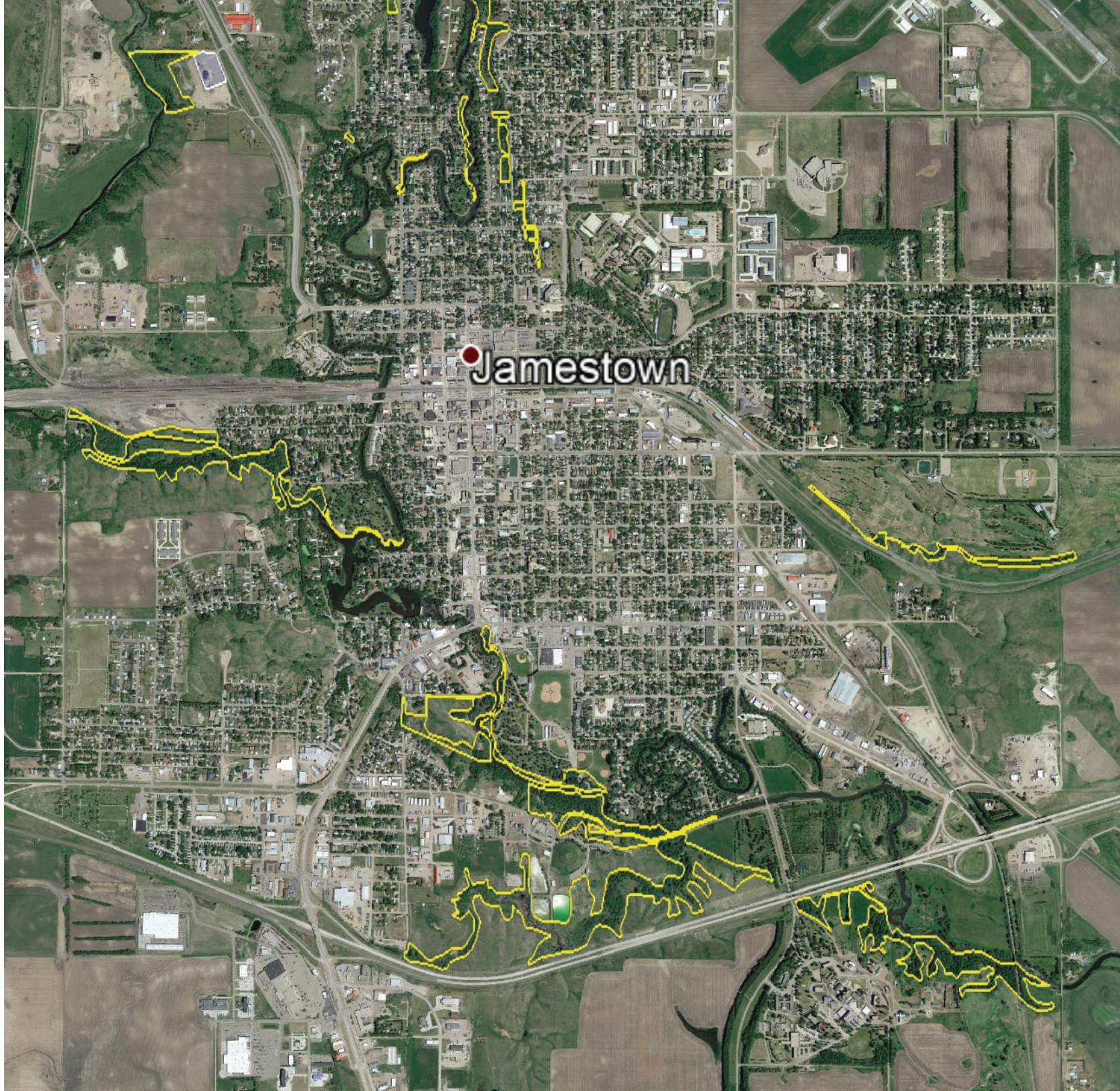

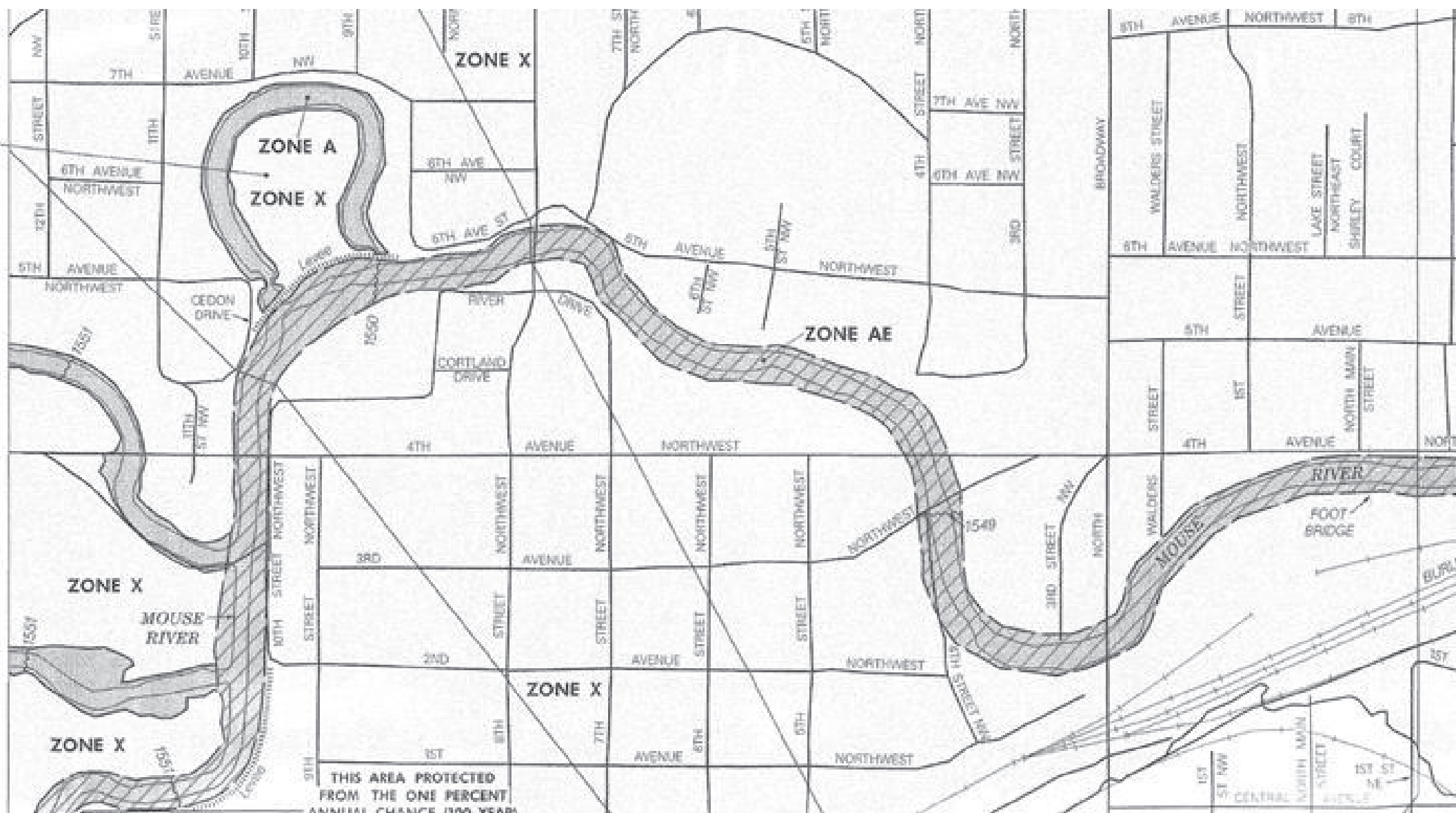
