Work Completed during Period Covered by Report:

We planted 4,338 Trees on the Ludden Youth Site on NE ¼ of 12-129-60 on April 26th, 27th and 28th of 2015. Shortly after that we received over 7 inches of rain in 3 days on May 10th in which we ending up losing about 1/3 of the new trees. There is an attached image from a drone plane that caught the north side of planting and showing where we got plastic on live trees and where the trees were lost. Due to the extreme wet and the timing of the available Dickey Soil Conservation Services in getting plastic down not till first of July, we had a lot extra dollars and time from our club members to prepare for plastic. The surviving trees look good now and a lot of the trees are coming out tubes that were installed, we will have to decide on this area if we should replant or leave it as additional food plots. This quarter of land we withheld from PLOTS and have designated as youth hunting only and have that it signed accordingly.

Update on 2014 project planting of the Rifle Range, this spring it was decided not to fill in missing trees that did not make it till next year due to we felt we had over 90% survival rate and some trees we were not certain if they would survive? Recent inspection of these trees showed us that we loss more due to no moisture at all from 2nd half of June till mid-August. We will plan on doing a fall inspection and count and plant hand plants where missing next spring on probably both plantings, this will probably be the extent of planting done in 2016 due to the high water table on next planting and would prefer to wait until a planned drainage project takes effect.
