We finally got control of the excess water on our larger property with some drainage allowing us to plant trees on this half section of property. In March we had a control burn on this section to remove excess cattails and prepare a seed bed. We then rented a tree planter and tractor and with the help of 10 adults and 24 Archers from the Oakes Archery Club to fund their trip to the World Archery trip to South Carolina planted 4,700 trees. See attached map with trees bordering the property that is in a CRP program and the adjacent food plots this property will turn into a wildlife haven. There will be a good blend of 25% waterfowl habitat even with this drainage along with duck nesting islands.

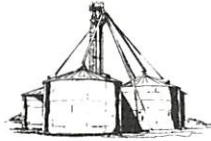
