On July 23, 2014 Contract 001-003 between Ducks Unlimited and the North Dakota Industrial Commission was fully signed and included a revised plan of activities that will be completed (Exhibit A). A Ducks Unlimited Civil Engineer began the engineering design plans for the 58-acre Alkali Creek Impoundment enhancement project located in Bowman County, ND. This wetland impoundment is managed by the North Dakota Game and Fish Department. We expect to complete this project enhancement work this fall.

The DU Civil Engineer and a DU Biologist met with landowner Jim Ehlert on the Jim Ehlert Dam project site this spring to discuss plans for restoring the function of this wetland impoundment. The dam is located on private land in Mountrail County, ND. DU performed the topography survey of the project site and the DU engineer has begun developing the engineering design for repairing and enhancing this wetland impoundment.
