Work Completed during Period Covered by Report: (This information will be posted on the Outdoor Heritage Fund/Industrial Commission website)

Since the execution of the agreement in April, significant progress has occurred toward project completion. Through the Prairie Pothole Wetland and Grassland Retention Program (PPWGRP), the Natural Resources Conservation Service (NRCS) has obligated 100 contracts worth \$1,741,397.85. These 100 contracts are spread over 15,549.20 acres. Some of the main practices that are cost shared under the PPWGRP program are, Upland Wildlife Management, Wetland Wildlife Management, Pasture and Hayland plantings, Cover Crops, Cross Fence, Water Facilities, Pipelines, Prescribed Grazing, Forage Harvest Management and Conservation Cover.

Now that the agreement between Ducks Unlimited and the Outdoor Heritage Fund has been signed, obligating the additional \$828,000 is now underway. For the past three months, Ducks Unlimited and NRCS have worked closely together to create an independent DU landowner agreement and the proper waivers needed to work with the producers enrolled in the program. Once all landowners are contacted and contracts signed, Fund dollars will be allocated, further providing incentives to producers for enhanced grazing lands and critical wildlife habitat. Additionally during the landowner contacts, the promotion of the ND Game and Fish Department PLOTS Program will occur.

While NRCS matching funds have been allocated, administrative duties were ongoing at the end of the reporting period. Therefore NRCS matching funds will be recognized next reporting period.
