
Producers have completed 2 contracts that I have paid out on. Loren Leininger installed 15,120 ft of fence. He received a cost share of \$6078.24 and matched that with \$4052.16 for a total project cost of \$10130.40.

Tyrone Larson planted 27 acres of alfalfa. He received a cost share of \$567.00 and matched that with \$378.00 for a total project cost of \$945.00.

I have several other contracts that are signed that are waiting to be completed that include fence, pipeline, water tanks, and prescribed grazing. These projects will receive a cost share of \$41,797.92. They will be paid as the practices are completed.
