Producers have completed 3 contracts that I have paid out on. Duane Feiring has completed a partial manure management system that allows him to feed his cattle out on cropland away from the feedlot inside the farmyard. He received a cost share of \$15,933.28 with the total project cost of \$26,555.46. Mike Haugen completed a large fencing project that included 27,425 ft. of fence. He received cost share of \$22,214.25 with the total project cost of \$37,023.75. This project allows Mike to rotate his cattle into several different sections within the pasture. Triple H Simmentals also completed a fencing project that included 7,000 ft. of fence. They received cost share of \$5,670.00 with a total project cost of \$9,450.00. This allows Triple H Simmentals to rotate their herd and better manage their pastures.

I have several contracts that are signed that are waiting to be completed that included fence, pipeline, water tanks, well, and partial manure management system. These projects will receive a cost share of \$31,088.64. They will be paid as practices are completed.
