## Garden Plan

As reported in the June 30 report, NRCS was contacted to develop a plan for the native plant and butterfly gardens in April. The final plan was accepted and initiated on May 8 by our camp development committee. The 40' by 157' terrace by the area of inspiration was sprayed by our maintenance person as instructed by the NRCS plan and the wall for soil retention was designed and marked out by extension staff. This was completed in 12 hours

Since that time, the native plant garden has been planted, mulched, and the retaining wall built. We have put some soil fill in the retaining wall area to complete the landscape. We invited a group of 4-H clubs to help us put in the plants and lay the landscape cloth for the main garden area. This took the group about six hours.

The trees were planted by a Morton County agent, a state specialist, and a volunteer marine lance corporal (former camper) in four hours. They also mulched the main part of the garden

and watered all the plants in about another two hours. Campers at our Great Outdoors camp week placed butterfly houses in the garden.



The retaining wall was built in four hours and filled during our fall camp close up by five extension staff and a bobcat. It will be necessary to let this settle until spring to finish filling and mulching it.

A modest estimate of total of \$1370 worth of inkind labor to construct the garden.



This is the front view of the garden. Some minor dirt work and grass seeding remains in the front of the wall for spring of 2016. The ends of the native plant garden will be cultivated and a broadcast of native plant seed will be put into each end of the remaining garden area. This is not part of the plan funded by OHF.
