Work Completed during Period Covered by Report: (This information will be posted on the Outdoor Heritage Fund/Industrial Commission website)

Progress on the Drayton Campground Project is proceeding on time and as planned. A Line of Credit for this project has been set up at KodaBank of Drayton, ND. The land that this project is to be completed on has been purchased by the Drayton Park District from Steve Simons for the purchase price of \$120,000.00. After some delays in clearing up CRP contract issues with the USDA office in Cavalier, ND, the official date of the purchase is December 31st 2014. The funds for this portion of the project were the result of a donation to the Drayton Park District from American Crystal Sugar for \$110,000.00, and a draw from the Line of Credit at KodaBank in Drayton, ND for the amount of \$10,000.00.

Other progress on this project has been limited to the purchase of some electrical components that were due for a substantial increase in cost. Items purchased were electrical wiring from Ryan Electric for the down payment of \$25,000.00. There items are currently being stored in a local warehouse until the ground warms up and installation of the wiring can commence. Since these expenses are not covered under this contract, the costs of these items are listed under the "Matching Funds" column and the money for these items came out of the Line of Credit at Kodabank.

As soon as the snow is gone and the ground warms up, the campground areas will be mowed and surveyed for the most efficient placement of the campsites, roads, bath house, and underground components of the Water, Sewer, and Electrical Lines. Also the permit process has begun with Burlington Railroad for the installation of the railroad crossing to be installed along Hwy 44 to the East of the campground. Construction of the roads and sites are scheduled for May 15th 2015 weather permitting. This project is still on track for a completion date of Sept.1 2015.
