On June 4th, the old playground equipment was removed by 4 community volunteers. The ground was then leveled and prepared for the new play structure.(taking 6 hours)

The new playground equipment was installed on September 10th and 11th with supervised installation from Bruce Schnieder (a certified playground safety inspector) with BC6 Builders out of Dickinson with 16 community volunteers. (taking 10 hours)

The timber and sand was placed on September 27th with 8 volunteers from Miller Honey (taking 5 hours). The sand is 12 inches deep and 7 feet away from the play structure.
