We recently installed four rows of trees and shrubs on an upland area adjacent to a riparian forest for the purpose of expanding forested acres for deer habitat. Tree and shrub species planted include eastern red cedar, rocky mountain juniper, bur oak and caragana. Each row is approximately 260 feet in length. Seedlings were planted on June 18 (photo below). Fabric was installed on June 25.
