Please see below the work completed during period covered by report.

On July 15, 2015, the North Dakota Forest Service (NDFS) received a grant from the North Dakota Outdoor Heritage Fund for \$1,800,000 to support this initiative. 100% of this money will be distributed to North Dakota landowners to support windbreak renovation projects. Each windbreak renovation project will follow a written windbreak renovation plan utilizing best management practices.

#### Technical Assistance

NDFS staff and partners offer technical assistance to interested landowners in the form of an on-site windbreak assessment and a written windbreak renovation plan. Renovation plans utilize a variety of forestry best management practices to meet the landowner's goals in restoring the functionality of the windbreak.

Requests for assistance were received through an online questionnaire. This questionnaire asked the landowner to answer a few simple questions including landowner contact information and the location of the windbreak in need of renovation. Questionnaires were grouped into "pools" based on the date that the document was received. The last batching period officially closed on April 30, 2019. Requests submitted since then have been addressed as staff time allows and weather permits.

As of June 30, 2021, NDFS has received over 820 total requests for windbreak renovation planning assistance statewide.


#### Financial Assistance

Following the windbreak assessment and written renovation plan, NDFS staff assist landowners with applying for cost share assistance to implement the windbreak renovation project. There was no deadline to apply and applications were accepted on a continual basis. Landowners have a minimum of two full years to complete their renovation project and apply for reimbursement.

As of June 30, 2021, NDFS has awarded grants totaling \$1,688,691.53 to 323 projects statewide, and 247 of these projects have been completed. The completed projects provide direct protection to 205 rural farmsteads, 4.64 road miles protected, and 1215.37 acres of farmland.
