Work Completed during Period Covered by Report:

The North Dakota Petroleum Foundation, in cooperation with the Outdoor Heritage Fund, industry partners and private landowners, planted more than 30,000 trees in Burleigh, Dickey, Emmons, Hettinger, Kidder, Morton, and Mountrail Counties in May and June 2019.

In addition, a monitor was out to count trees for the 2018 planting season. Unfortunately, wet weather throughout much of the fall and early snows in October and November prevented monitors from reaching all projects. The monitor was able to check 9 of the 18 projects from that year. Attempts will be made to monitor the remaining projects in the spring of 2020.

Of the 9 projects totaling 25,550 trees, approximately 8,995 trees survived. Drought in 2018 and extreme wet weather for some areas in 2019 took a toll on several of the projects. Planting for the Future will work with landowners to discuss planting of replacement trees in 2020 or 2021.

The expenditures in this report include contract labor and program administration for 2019 plantings, planning for 2020 plantings and monitoring for half of the 2018 plantings.

The goal of this grant was to plant 55,000 trees over the three-year period of this grant. Over two planting cycles, Planting for the Future was able to plant 88,000 trees. Because of this, all grant funds have been expended, but the North Dakota Petroleum Foundation will continue filing reports in the third year of the grant to report on additional monitoring activities and work with landowners to replant trees to ensure stronger projects for habitat.
