Work Completed during Period Covered by Report:

Since receiving the OHF grant award for the Stutsman County Prairie Management Toolbox, Audubon Dakota has cooperated with the Stutsman County Soil Conservation District and the U.S. Fish and Wildlife Service to identify landowners that would benefit from the Toolbox program.

To date, Audubon Dakota has entered into agreements with 7 landowners within Stutsman County, with the potential to positively impact 3,314 acres through grazing infrastructure installation and invasive species removal between 2018 and 2019.

One phase of a 3-phased project had been fully completed in 2018, which installed 9,700 feet of fence on approximately 76 acres. Project total was \$17,460.00, with the landowner responsible for \$6,984.00 and OHF grant dollars contributing the remaining \$10,476.00. The next 2 phases of this project will be completed in 2019.
