Photo 1. Marginal acres within cropland are being converted to perennial cover. This cover will help rebuild organic matter, increase infiltration, sequester carbon, and provide habitat to wildlife species while reducing inputs.



Photo 2. A buffer of perennial cover will be installed through PATCH along this stream. The establishment of perennial cover will help reduce runoff and sedimentation by capturing sediments and increasing infiltration.
