The shared use pathway along newly constructed Reservoir Road and along the Stanley City Pond is complete. In May 2020, Martin Construction was awarded low bid in the amount of \$1,117,327.73, \$714,070.44 of this amount was for the Reservoir Road Reconstruction Project and \$403,257.29 for the Shared Use Pathway Project to the Stanley City Pond. All work under the contract with Martin Construction including any change orders is complete for the 9' asphalt pathway project. The total cost paid to the contractor for the shared use pathway project was \$386,461.98.

The engineering for the project was done by Brosz Engineering. The cost of engineering consisted of \$35,835 for preliminary engineering and \$36,065 for construction engineering for a total engineering cost of \$71,900.

Total project cost was \$ 458,361.98 which does not include the in-kind work to be done by the City of Stanley, Scouts and volunteers. The in-kind and volunteer match was completed in July, 2022. The trees were planted the beginning of June 2022 with help from the Scouts and civic minded volunteers. The City with the assistance of the volunteers will continue to water and maintain the trees to make sure they have a good start. The total in-kind match was \$11,567.68 and the volunteer match was 1,076.25 for a total of \$12,643.93.

The project provides safe access to the Stanley City Pond and has already proven to be successful as many are using the pathway. Signage recognizing the Outdoor Heritage Funding used towards this project has been received and will be installed by the Public Works Department. The City also moved forward with a "Memory Bench" project along the pathway with \$6,400 being donated for benches. The benches will be installed at the same time as the sign. The benches were not included in the total in-kind cost as this was not part of the project when submitted.

In addition to the trees and benches, the ND Game & Fish Department added to the success of the overall project by assisting the City of Stanley with cleaning of the shoreline and providing a T-shaped floating fishing pier to replace the existing fishing pier at the Stanley City Pond. Also, the Reservoir Road Reconstruction Project, adjacent the shared use pathway, was done with matching funds from the Special Road Funds through the ND Department of Transportation.
