## Attachment 1 - Work Completed 9-26-2020 through 11-24-2020

## Cannonball River Fish Passage at Karey Dam

Rachel Contracting completed the subgrade excavation the week of September 28th. Shaping of the embankments and the adjacent land continued while Rock gradation tests were performed. Granular filter and rip rap delivery to the project started on October 5th. The contractor started installing the geotextile fabric that week as well, working in sections starting at the downstream sheet pile.

The final riffle was installed the week of October 12<sup>th</sup> and the remaining sheet pile was installed on Friday of that week. The chink rock was placed the following week.



Rachel Contracting finished placing all imported material for the rock riffle structure by October 20th. The contractor removed the water control structure, topsoiled the laydown areas, finished



reclaiming the adjacent property and removed the silt curtain. The site camera was removed on October 21st as the contractor started to mobilize off site.

Seeding and restoration was halted as a result of snow for a week but was completed November 6<sup>th</sup>. Barr completed a semifinal walkthrough with the contractor and the client on October 21<sup>st</sup> and the final walk through to inspect seeding on November 6<sup>th</sup>.
