Work Accomplished*:

Trees on the shoreline that needed to be removed was completed in October 2020. Advertised bids December of 2020 and opened bids January 2021. Awarded bid to ABC Docks from Bismarck, ND. Dock and gangway was installed in early June 2021 and the dock and gangway was ready for use on June 15, 2021. We have not installed the storage shed on the dock as we have kayak holders on the dock and life jackets are stored at the Clubhouse. We will be installing a sign soon recognizing contributors.
