## Goal of Project\*:

The goal of the project is to alleviate the safety concerns of uncontrolled seepage through the dam embankment. The project installed a toe drain along the downstream side of the embankment east of the existing spillway. The project will benefit the existing recreational and natural resources that exist as a result of the reservoir of the Silver Lake Dam by increasing the stability of the embankment by cutting off and draining the seepage path within the dam embankment.

#### Work Accomplished\*:

The project installed a toe drain along the downstream side of the embankment east of the existing spillway, and removed vegetation from the dam embankment including a large tree located directly within the embankment. The rootball was removed with aid of a cofferdam, and the embankment reconstructed where the rootball was located.

## Project Results\*:

The toe drain is functioning as planned. Flow was observed to begin draining from the toe drain shortly after installation of the drain.

#### Value to North Dakota\*:

This project allows for Silver Lake dam to continue to provide the current level of recreational and habitat benefits that it has for many decades. This facility is the only one of its kind in Sargent County, and is highly regarded within the county.
