Goal of Project*:

The goal of this project was to update the playground equipment at Writing Rock State Historic Site. The original equipment was outdated and no longer safe. The State Historical Society and Divide County worked together to modernize the equipment, make it safer and encourage more families and schools to visit the site.

Work Accomplished*:

The Divide County Highway Department removed the old equipment and prepared the ground for the installation. On November 14th, the installation of the new equipment was completed. A recognition sign was ordered and will be placed once the weather improves.

Project Results*:

Overall, we feel the project is a success. Since the new equipment was installed in November, it has not had much opportunity for use. We are looking forward to seeing it be used this season by school groups and the general public. The project has also created a partnership between SHSND and Divide County. On April 30th, we will be officially opening the playground with a joint event. We will continue to improve the site with

programming, a walking trail and a project with the ND Arts Council.

Value to North Dakota*:

Writing Rock is located in rural northwestern ND. It is an important historic site, but it is a resource for the local community. It used to be a site for family gatherings, camping, and community events. The upgraded playground equipment will offer visitors more experiences and reasons to visit the site. It is the first step towards improving the site and shows that ND has pride in its historical and cultural sites.

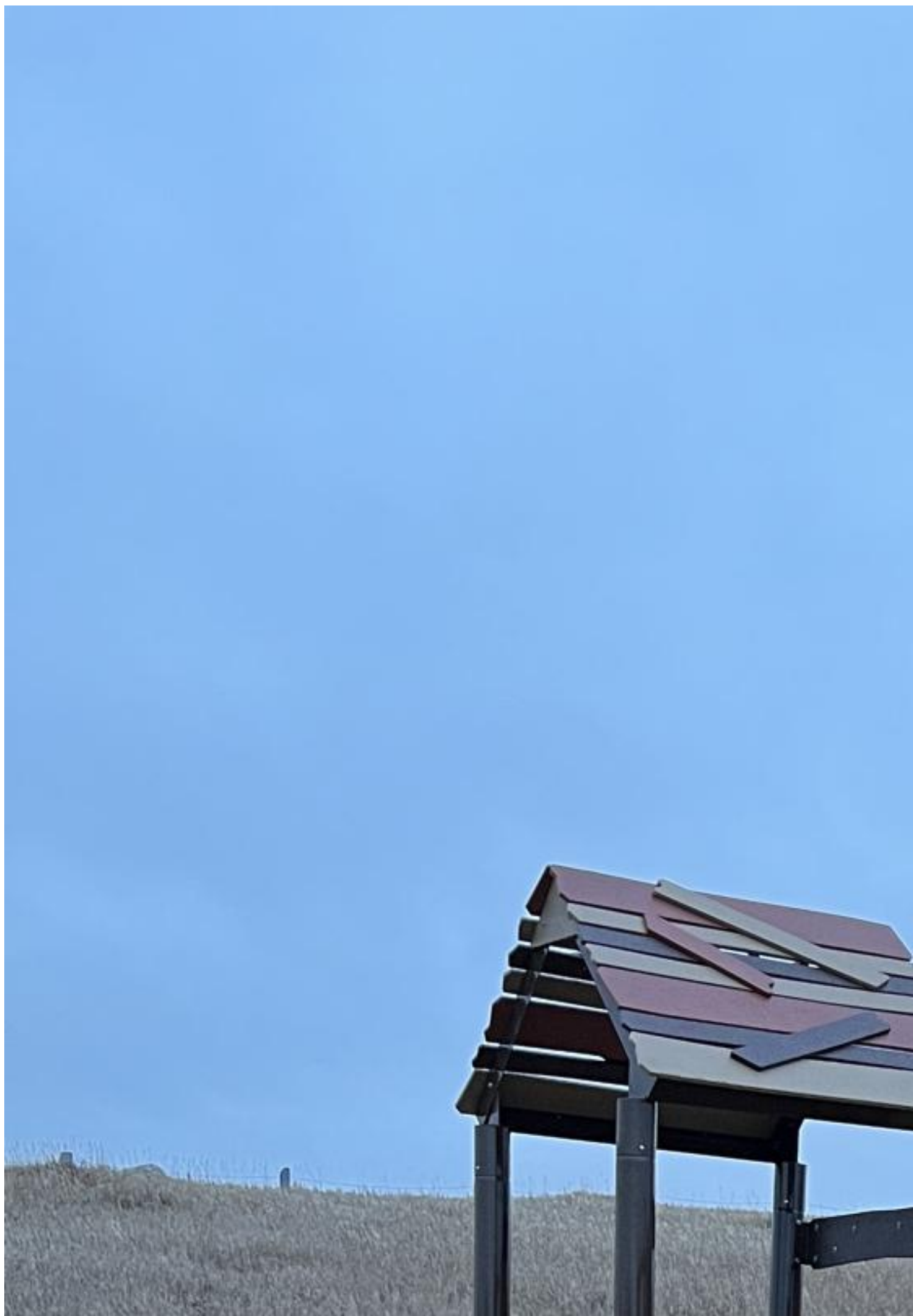

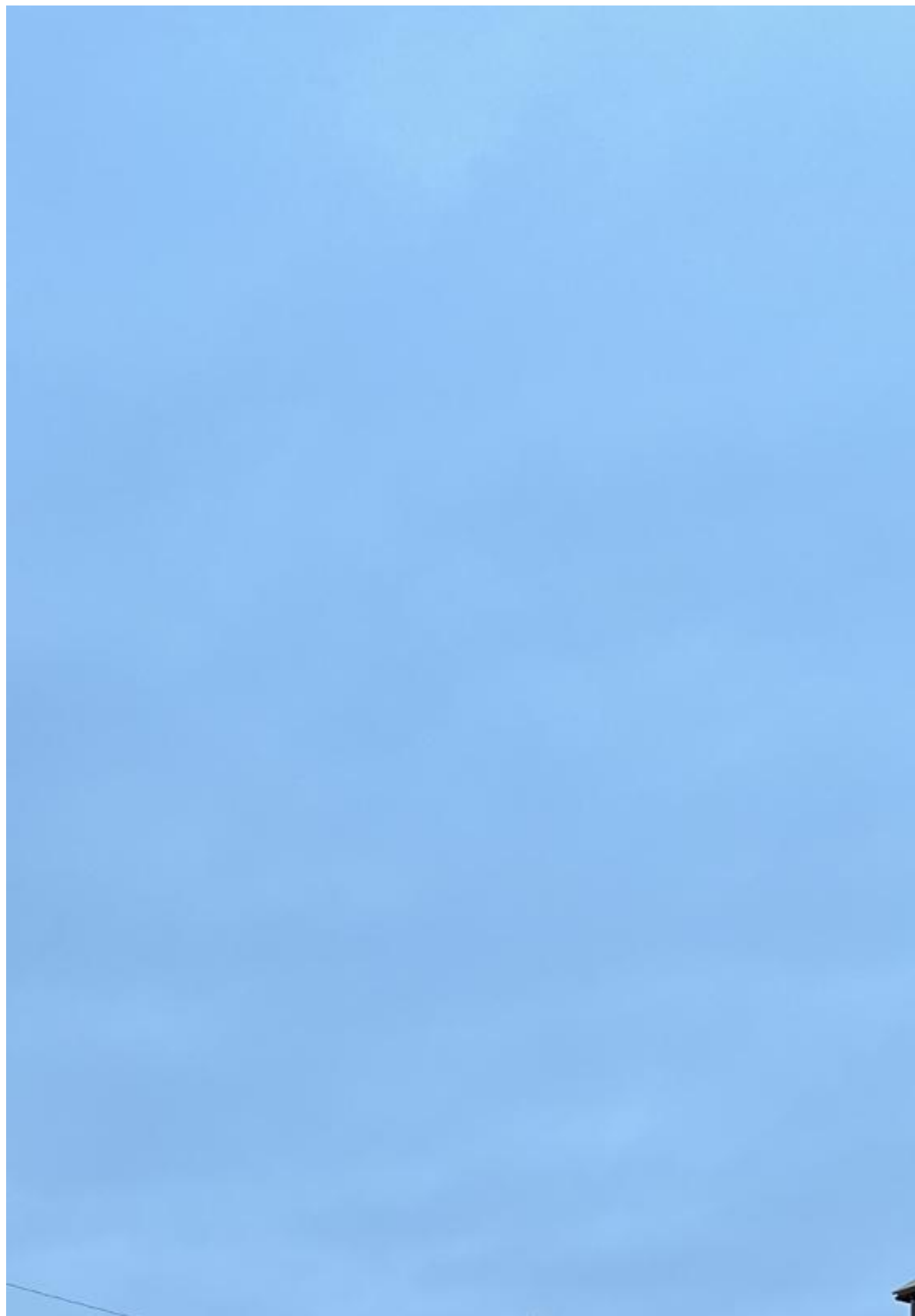
