Grant applications were posted on the NDFS website and made available to all interested parties. In 2021, NDFS awarded grants to 20 landowners. As of February 28, 2022, one renovation project has been completed, resulting in the restoration of 7 acres of forest. \$11,274.42 of grant funds have been expended. 19 renovation projects are in progress with \$128,034.25 in estimated grant funds committed. Total grant funds obligated \$139,308.67. Actual reimbursements will be based on actual costs.
