Budget Narrative

Budget Narrative:

This OHF grant proposal is requesting \$720,000 in grazing developments and landowners will provide \$480,000 in match. Grazing Systems will consist of installing fencing and water developments on private property to be managed by livestock grazing. Fencing will follow the NRCS Office Tech Guide Allowable Cost; the full funding rate will be determined by NRCS's practice scenario amount. The grant will provide landowners a 60% cost-share payment. All fencing cost-share will be paid based on a rate per foot of fence and type of fence installed. Landowners will provide the remaining 40% cost-share. Water Developments will follow the NRCS Office Tech Guide Allowable Cost; the full funding rate will be determined by NRCS's practice scenario amount. The OHF grant will use 60% cost-share of these rates for agreement development, but will pay based on actual costs. The landowners will provide the remaining 40% cost-share. The Trust will provide up to \$10,000 at a 60% cost-share for water developments that would not be eligible for cost-share by OHF. These may include portable equipment, portable power supply or other equipment costs. The Trust will provide \$125,000 in lease payments. These habitat leases consists of a payment to the landowner for any CRP acres expiring in 2022 and 2023. The lease rate will be \$5.00 per acre per year, so landowners will receive a \$50/acre one-time payment for the 10 year agreement. Lease payments will be on expired/expiring CRP acres only. The grant proposal is requesting \$10,000 of OHF funds for contracted services and support. The OHF funds will be used for cultural reviews, marketing and project implementation. The Trust will provide \$10,000 in cash match for these and all other services listed. Contracted services and support will consist of services for items such as engineering, cultural resources, surveys, specialized equipment rentals, soil testing, habitat assessments, marketing through North Dakota Conservation District Employees Association's ND Conservation Partnership and Delivery Initiative, partnership coordination meetings and for any additional delivery and/or program monitoring. If Contracted Services funds are not utilized during the grant period for these services, the funds would be used for additional conservation practices identified in the proposal. The grant proposal is requesting \$10,000 in OHF funds and Trust/Partners are providing \$45,000 of in-kind match. Project delivery will consist of actual time to complete program promotion and outreach, meeting with landowners, providing technical assistance, completing landowner agreements, partnering with state, federal, local, and nongovernmental organizations, processing payments, providing agreement monitoring, and completing all grant administration. The Trust is providing \$30,000 of in-kind match for staffing costs include salary, benefits, and travel. The partners will provide staffing through in-kind contributions. DU is providing \$7,500 of in-kind match. The USFWS Partners for Wildlife Program is providing \$7,500 of in-kind match.

Abstract/Executive Summary*:

North Dakota's wildlife populations have been the beneficiary of the U.S. Department of Agriculture's Conservation Reserve Program (CRP) authorized through federal Farm Bills since the mid-1980s. Currently, there are 1.2 million acres of CRP enrolled in North Dakota. In the next two years just under a half-million acres of CRP are set to expire. As many CRP contracts are set to expire, landowners are determining their options for these acres. These options could include re-enrollment back into CRP, crop production and grassland production. It may possibly be true that some of the acres will be re-enrolled back into CRP, but many landowners will choose to transition the expired CRP acres into cropland production. This grant application would assist landowners wanting to transition those CRP acres into working grassland production. Through the Working Grassland Partnership (WGP6) the North Dakota Natural Resources Trust and partners propose to assist landowners in this transition by offering a one-time lease payment, cost-sharing of fencing and cost-sharing water developments necessary for livestock grazing. The WGP6 grant proposal is a new phase of the Working Grassland Partnership (WGP) applications previously supported by the Outdoor Heritage Fund Advisory Board and North Dakota Industrial Commission. The Trust and partners appreciate the past support to the WGP and reception by OHF of the importance of working grasslands role in enhancing and maintaining the viability of grassland habitat. Even with significant past assistance the interest in WGP continues to increase. The WGP6 will be offered statewide. In 2022 over 387,000 acres of CRP are expiring and in 2023 over 102,000 acres of CRP will expire in North Dakota. The the following counties have the highest acreage of expiring CRP: Bottineau (28,000), Nelson (23,000), Stutsman (22,000), Walsh (22,000), McHenry (20,000), Rolette (20,000), Ramsey (18,000), Burke (17,000), McLean (15,000), Barnes (15,000), Burleigh (14,000), Eddy (14,000), Divide (13,000) and Hettinger (13,000). These counties comprise 50% of all expiring CRP acres in next two years. North Dakota ranchers are very interested in developing reliable water sources, increasing rangeland management, being part of the solution of declining grassland bird populations, partnering on cost-share of infrastructure development and receiving technical assistance. This grant proposal combines the unique opportunity to improve soil and water management, benefit the conservation of wildlife species and provide a working lands concept for livestock producers.

Organization Information*:

The North Dakota Natural Resources Trust was created in 1986 and was originally called the North Dakota Wetlands Trust until 2000. The Trust's mission is to preserve, restore, manage, and enhance wetlands and associated wildlife habitat, grasslands, and riparian areas in the state of North Dakota. The Trust achieves this mission by partnering with agricultural and conservation organizations to: 1) promote the productive use of private agricultural lands that result in the enhancement and protection of private lands; 2) effectively use North Dakota's public lands both for agriculture and recreation; 3) promote good land use planning along urban river corridors, and 4) enhance the state's significant water resources. The Trust helps shape the landscape through its programs and does its best to help shape both public attitude and public policy to support natural resource protection. From its inception, the Trust has played a role as facilitator between agricultural and conservation interests. In addition to facilitating and funding sound, on-the-ground conservation of natural resources, its goal is to identify common issues, create dialogue, and resolve conflicts. Purpose of Grant*:

Statewide, there will be just under 500,000 acres expiring from the CRP in 2022 and 2023. Landowners will have to make a decision on retaining the CRP as grass cover or converting the land back to cropland. This proposal aims to assist landowners who want to transition these acres into

working grasslands. The need for additional rangeland acres has never been higher. This is driven by past drought conditions and past grassland conversion. Many producers are looking to secure additional grazing acres for their operations. While it feels like most of the agricultural focus in on crop production, this proposal will be a very useful option for livestock grazers. Using expired CRP for grazing has proven to be a beneficial option for grazing, landowners (including absentee landowners) and wildlife. Depending on the interest of the landowner with expiring CRP, connecting them with a livestock owner can provide a solution with many benefits. Developing a grazing plan for expired CRP acres promotes the building of strong relationships between producers and CRP landowners. Without being aware of the livestock grazing alternatives, CRP landowners may gravitate back to planting crops out of financial concerns or lack of options. As a result of past WGP successful grants, there is a collective partnership of agencies and organizations familiar with how WGP works and are willing to guide landowners exploring their options on how to transition expired CRP acres into working grasslands. These federal, state and non profit organizations will be a critical part of creating new landowner partnerships under WGP6. WGP6 will focus on retaining grasslands from expiring 2022 and 2023 CRP contracts. The fate of many of the 2022 expiring acres are being decided right now, so it is imperative to have funds available so that landowners looking to retain these acres in grassland have financial options and technical assistance to develop long term plans for their property. By providing 60% cost-share on livestock and bird-friendly developments, the grant has a goal of signing agreements on over 7,500 acres. This proposal is asking for OHF to provide funding for grazing system developments that include livestock water and fencing. The Trust will also provide a habitat lease only on acres expired from CRP. This would be a one-time, upfront payment that would be issued when a WGP6 agreement is signed. The habitat lease will serve as an additional incentive to keep these acres in grassland. Technical advice, such as grazing plans, will be provided by the supporting partners. Landowners are also informed about possible NDGFD PLOTS payments on land in and around the WGP6 program acres. The WGP6 aims to build on the success of previous WGP grants by continuing to enhance grassland productivity and condition, water quality, soil health, and wildlife habitat for grassland birds. Equally valuable, this will improve the sustainability and profitability of many existing livestock operations. By supporting grazing infrastructure we believe these former CRP acres will transition into working, bird-friendly grazing lands for long-term livestock operations. In addition to the WGP6, landowners will be informed of additional opportunities through the Meadowark Initiative. The Meadowark Coordinator will be an additional resource for landowners looking for other potential grassland based programs that could further enhance their ranches. Meadowlark Initiative's focus is to help producers remain profitable and productive while supporting grassland dependent wildlife. Please list the counties that would be impacted by this project:

The Trust will oversee and coordinate all activities associated with the WGP6 proposal. WGP6 will be offered throughout the entire state of North Dakota. The Trust will develop site specific agreements with landowners which will include a map defining boundaries, the payments amount, matching funds, landowner contributions and the Trust matching funds. All agreements will be signed and dated by the landowner and the Trust. The Trust's staff will coordinate the WGP6 program from our office located in Bismarck, ND. The Trust will monitor all WGP6 agreements. Evaluations and progress reports will be completed. The Trust's programs are structured to be flexible and accommodating to agreement participants. Maintaining good communication with agreement participants and the partners is critical to the project. Indicate how the project will be funded or sustained in future years. Sustainability*:

The WGP6 will be a voluntary option available for only private landowners in North Dakota. When the partnership of OHF, conservation organizations and private landowners is achieved through working lands conservation, it is a win for every citizen of the state. WGP6 will help preserve our ranching heritage and ND's natural resources. We believe by enhancing and maintaining the viability of grassland cover and establishing sound foundation for continued livestock production based on the desires of the landowners and producers that many of these costshared developments will remain in place for many years after the life of this project.

Partial Funding*:

The Trust thanks the OHF Advisory Board and North Dakota Industrial Commission for their past support of Working Grassland Partnership grant proposals and the consideration of this WGP6 proposal. If the proposal receives partial funding, this will lower the number of agreements with landowners, resulting in less acres achieved, and reduces the ability to leverage additional funds through the in-kind match available by the Trust, partners and landowners.
